DESCRIPTION OF BUILDING PRODUCT

Airco Brands supplies clouds (branded Otter) that are intended for fixing non-load bearing thin sheet material to timber. Applications include fixing sheet metal signage, clips and saddles to timber.

Otter clouds can be used in interior and exterior applications.

The clouds have a large flat rounded head with 90° angle between the head and shank, a plain shank and are hot dipped galvanised or 316 grade stainless steel. They are supplied in a two thicknesses of 2.5 mm and 2.80 mm with lengths ranging from 20 – 40 mm.

These clouds are supplied only in loose packs, and are not suitable for use with a staple gun.

Otter Products covered by this BPIR are identified with the prefix CLPG and CLPS.
