DESCRIPTION OF BUILDING PRODUCT

Airco Brands supplies open, blind and flange rivets under the Otter brand. They are supplied in different finishes which determines the application; interior or exterior. Otter rivets provide holding power from 670 – 5340 N in both open and sealed jointed systems.

Steel rivets are only suitable for interior uses and are compatible with zinc/alum alloy, aluminium extrusions and galvanised steel.

Aluminium or 316 stainless-steel rivets should be used for exterior applications and may be used for interior.

Aluminium rivets are compatible with zinc/alum alloy, aluminium extrusions and galvanised steel. 316 Stainless steel rivets are compatible with stainless steel, copper and brass and may be used in all environments.

Airco Brands supply Otter Colorbond® rivets which are supplied in different colour options for use where colour matching is required.
