DESCRIPTION OF BUILDING PRODUCT

Airco Brands supplies staples under the Otter brand. They are,

- supplied with sliced points, and with or without a barb.
- manufactured from cold forged U -haped galvanised wire
- 12 – 50 mm in length and with shank diameter of 2.0 - 4.0 mm.

Staples have the advantage of providing good holding power and are quick and easy to use. Barbed shanks provide additional holding power.

Otter staples are suitable for interior and exterior applications including fixing of wire and mesh as well as in cabinet making.

They are supplied in loose packs and are not suitable for use with a staple gun.

Products covered by this BPIR are identified with the prefix STBG and STPG.
