Airco Brands supplies EPDM washers under the Otter brand. They provide a seal against wind and rain when used in conjunction with a fastening.

EPDM (ethylene propylene diene monomer) is an M-Class rubber that is used as roofing, pool liners, sealants, and washers. EPDM is UV stabilised, has high elasticity, and low carbon content to minimise or eliminate conductivity.

Otter dome washers are supplied for use in conjunction with fixing profiled claddings or roofing.

Products covered by this BPIR are identified with the prefix DOME.
